## Post-Secondary Financial Assistance Agreement

In return for financial assistance to pay unmet tuition, books, and fees related to receiving my educational training at the institution that I am currently enrolled in and any other institutions I may attend in the future:

I agree to maintain a 2.0 or better semester and cumulative grade point average and provide a copy of my grades at the end of each semester/quarter to the Independent Living Coordinator named below. If my cumulative GPA drops below a 2.0 I understand that I will receive a warning and have 1 (one) semester to achieve a 2.0 or better. If I receive less than a 2.0 for 2 consecutive semesters/quarters I understand that I will be suspended for 1 academic year from ILP (if you are between the ages of 18-21). If I receive less than a 2.0 for 2 consecutive semester and I am over 21 I understand that I will no longer be eligible for ILP post-secondary support and my ILP case will be closed. I agree to provide a copy of my school schedule and an academic prospective for my chosen major with an anticipated graduation date to the Independent Living Coordinator at the start of each semester/quarter.

I agree to take only the courses required for my major of choice. If I must take a course twice, I will contact the Independent Living Coordinator for permission. If I fail to notify the coordinator I will be responsible for paying for taking the same course twice. Initial \_\_\_\_\_

I agree to apply each year for all financial aid, scholarships, and grants, which may include loans (if you get a loan you will be responsible for repaying the full loan) and understand that all funds received either through the Pell Grant, SEOG, Hope Grant, and/or the Independent Living Program, are to be applied directly to my school bill before ILP funding is disbursed. I agree and understand that any purchases made at the school bookstore being charged to my school bill will consist *only* of required books. Supply purchases must be approved by the ILC.
